

# ASTHMA MANAGEMENT

## PURPOSE

This policy will outline the procedures to:

- ensure ECTs/educators, staff, and families are aware of their obligations and the best practice management of asthma at Denzil Don Kindergarten
- ensure that all information required for the effective management of children with asthma enrolled at Denzil Don Kindergarten is collected and recorded so that they receive appropriate attention when required.
- ensure requirements for medical management plans are provided by parents/carers of asthmatic children.
- ensure Asthma Action Plans are provided by parents/carers for asthmatic children before their commencement.
- develop risk-minimisation and communication plans with parents/carers.
- respond to the needs of children who have not been diagnosed with asthma and who experience breathing difficulties (suspected asthma attack) whilst at the service.
- ensure ECTs/educators, staff, and families follow the advice from Emergency Management Victoria associated with thunderstorm asthma events.



This policy should be read with the *Dealing with Medical Conditions Policy*.



## POLICY STATEMENT

### VALUES

Denzil Don Kindergarten is committed to:

- providing a safe and healthy environment for all children enrolled at the service.
- providing an environment where all children with asthma can participate to their full potential.
- providing a clear set of guidelines and procedures to be followed with regard to the management of asthma.
- educating and raising awareness about asthma among educators, staff, families, and any other person(s) dealing with children enrolled at the service.

### SCOPE

This policy applies to staff, students, volunteers, visitors, parents/carers, children, and others attending programs and activities at Denzil Don Kindergarten, including offsite excursions.

Asthma management should be viewed as a shared responsibility. While Denzil Don Kindergarten recognises its duty of care towards children with asthma during their time at the service, the responsibility for ongoing asthma management rests with the child's family and registered medical practitioner.

## BACKGROUND AND LEGISLATION

### BACKGROUND

Asthma is a chronic, treatable health condition that affects approximately one in nine Australian children and is one of the most common reasons for childhood admission to hospital. With good asthma management, people with asthma need not restrict their daily activities. Community education assists in generating a better understanding of asthma within the community and minimising its impact.

Symptoms of asthma include wheezing, coughing (particularly at night), chest tightness, difficulty breathing, and shortness of breath; however, symptoms may vary among children. It is generally accepted that children under six years of age do not have the skills and ability to recognise and manage their asthma without adult assistance. Because of this, services have a requirement to educate staff and families about asthma and promote responsible asthma management strategies.

Legislation that governs the operation of approved children's services is based on the health, safety, and welfare of children and requires that children are protected from hazards and harm. The approved provider will ensure that there is always at least one educator on duty who has current approved emergency asthma management training in accordance with the *Education and Care Services National Regulations 2011 (Regulation 136(c))*. As a demonstration of duty of care and best practice, ALL Denzil Don Kindergarten staff have current approved emergency asthma management training (*refer to Definitions*).

## DEFINITIONS

The terms defined in this section relate specifically to this policy. Refer to the definitions file on the kindergarten website for regularly used terms.

**Approved Emergency Asthma Management (EAM) training:** training approved by the National Authority in accordance with Division 7 of the National Regulations and is listed on the ACECQA website. EAM training provides knowledge about asthma's underlying causes and triggers, as well as the recognition and treatment of an asthma attack.

**Asthma Action Plan:** a written plan detailing a child's asthma and its management, including contact details, what to do when it worsens, and treatment to be administered in an emergency. An Asthma Action Plan template specifically for use in children's services is available from Asthma Australia's website:

**Asthma emergency:** the onset of unstable or deteriorating asthma symptoms requiring immediate treatment with reliever medication.

**Asthma Emergency Kit:** should contain:

- reliever medication
- 2 small volume spacer devices
- 2 compatible children's face masks (for children under the age of four)
- record form
- asthma first aid instruction card.

It is essential to have at least two spacers and two face masks in each first aid kit, and these should be washed with warm, soapy water if used.

**Asthma triggers:** things that may induce asthma symptoms, such as pollens, colds/viruses, dust mites, smoking, and exercise. Asthma triggers will vary from child to child.

**Metered dose inhaler (puffer):** a standard device used to administer reliever medication.

**Puffer:** common name for a metered dose inhaler.

**Reliever medication:** a blue/grey metered dose inhaler containing salbutamol, a medication used to relax the muscles around the airways to relieve asthma symptoms. This medication is always used in an asthma emergency. Reliever medication is sold by pharmacies as Airomir, Asmol, Ventolin or Zempreon.

**Risk minimisation plan:** provides information about a child's asthma triggers and strategies to avoid them in the service (refer to Attachment 3).

**Spacer:** a plastic chamber device used to increase the efficiency of delivery of reliever medication from a puffer. It should always be used in conjunction with a puffer device and may be used with a face mask.

- notifying stakeholders affected by this policy at least 14 days before making any significant changes to it or its procedures unless a lesser period is necessary due to risk (*Regulation 172 (2)*).
